Ms. Carley Trask, environmental engineer from SWFWMD (South West Florida Water Management District) attended and spoke on various topics, including what the examination every 5 years entails, (primarily looking at our water discharge into county and state waterways). Discussed various permits UPCC has and has had since the early 1990s. She indicated that they track retention and detention ponds and also the difference between three areas, conservation areas, wetlands and preserves (a county requirement). Since University Park Country Club was permitted by SWFWMD, there has been 28 revisions to our permit. Ms. Trask also noted that based on her information, UPCC has been actively managing its ponds very well. She also commented about vegetation, littoral shelfs and other water flow features that we have weirs and culverts. Committee members also asked her to check on a few of our troublesome ponds, via our pond numbering system.

Our next two topics has to be postponed until our next meeting (June 10, 2021) as Curtis Nickerson was not able to attend our meeting. The Pond testing discussion, the use of Alum and whether UPCAI can be relieved of the responsibility of the three ponds outside of UPCC and north of Honore.

Next up was the discussion of our individual committee member's inspection of each of our 53 ponds. We were asked walk around and to look for Algae levels, Bottom weeds, Erosion, Littoral Shelf, Shoreline Debris, Weir/ Culvert repair, Fish/ Wildlife Kills, Bulkheads, and to make comments about each. These findings will be passed on to the appropriate body. We intend to do these inspections

throughout the summer and to continue to get familiar with the various conditions and changes of the ponds.
